Course Purpose	To provide local musicians with opportunities to train as professional orchestra musicians, develop their musical performance skills, and increase their employment opportunities in professional orchestras.

Target Applicants	(1) Macao residents who aspire to become professional orchestra musicians (2) Possess good playing ability and experience with any of the instruments currently used in the Macao Orchestra's standard orchestration, including: Flute, oboe, clarinet, bassoon, horn, trumpet, trombone, percussion, violin, viola, cello and double bass.
Application Requirements	(1) Holder of valid Macao Resident Identification Card (2) At the beginning of the Training Programme (1 September 2026) must possess a Bachelor of Music degree or higher in the corresponding performing instrument.

<p>Training hours</p>	<p>(1) The entire Training Programme lasts for one season (i.e., from 1st September to 31st July of the following year, 11 months).</p> <p>(2) The maximum number of lessons per season is 176. The length of each lesson is arranged by the instructor in charge, with a maximum of 3 hours per lesson;</p> <p>(3) The average number of lessons attended per month is approximately 16. The specific monthly lesson schedule and arrangements are arranged by the Macao Orchestra, but the maximum number of lessons attended per month shall not exceed 30;</p> <p>(4) Lessons will have the chance to be held in the evenings, on weekends and public holidays.</p>

Certificate	<p>Each Programme spans one concert season: an exam is required before the end of the season, and a course certificate will be awarded only if the following conditions are met:</p> <p>Pass the Programme exams (“Professional Performance”) and pass the “Daily Performance” assessment (such as daily attendance and discipline);</p> <ul style="list-style-type: none">■ Participants must achieve an attendance rate of 80% or higher [Attendance Rate = (Number of Attended Sessions / Total Number of Sessions) x 100%] to be eligible to take the Programme completion exam. Failure to meet the attendance requirement will result in termination of the training qualification for this Programme. <p>The Programme’s “Professional Performance” exam is conducted in two phases and will be graded according to the following criteria:</p> <ul style="list-style-type: none">● The first phase is expected to take place in January 2027, requiring students to perform in a chamber music concert of approximately 30 minutes. The first phase exam accounts for 40% of the “Professional Performance” exam score;● The second phase is expected to take place in July 2027, where students will need to participate in a solo and chamber music ensemble concert of approximately 50 minutes. The second phase exam will account for 60% of the “Professional Performance” score. <p>“Daily performance” will be evaluated by the Orchestral Operation department according to the criteria outlined in the student handbook and guidelines.</p> <p>Note 1: If a student fails the examination (“Professional Performance”) or the “Daily Performance” assessment, they will not receive a certificate at the end of the season.</p>

Scholarship	<p>(1) The scholarship for this Training Programme is MOP 143,000.00, which will be paid in 11 monthly installments (MOP 13,000.00 per month).</p> <p>(2) Students must participate in all lessons and activities arranged by the orchestra each month. Except in special circumstances, if a student fails to attend all lessons and activities arranged by the orchestra each month, the student will not receive the corresponding month's installment scholarship; if the student's attendance rate is 100% each month, the scholarship for that period will be awarded in the following month.</p> <p>(3) If a student is absent due to special circumstances, they must provide a sufficient and reasonable explanation and/or attach relevant proof issued by an institution recognized by the Macao government, and must be accepted by the Executive Director of the Macao Orchestra Limited and the Music Director and Principal Conductor of the Macao Orchestra. In the case of the above special circumstances, the student's monthly attendance rate in this course and activities must not be lower than 80%, and the corresponding monthly installment scholarship will be awarded according to the attendance rate; if the student's monthly attendance rate is lower than 80%, the student will not be awarded the corresponding monthly installment scholarship; if the student's total attendance rate for the season is determined to be lower than 80%, their training qualification will be terminated immediately.</p>

Training Programme Outline	<p>(1) Receive intensive orchestral training;</p> <p>(2) Each student will be paired with a musician from the Macao Orchestra, who will provide professional performance lessons and provide feedback to the student on each rehearsal and performance class.</p> <p>Lessons including:</p> <ul style="list-style-type: none">■ One-on-one instrument lessons■ Attending orchestra rehearsals and performances■ Rehearsing and performing with orchestra musicians■ Participating in chamber music lessons■ Mock orchestra audition■ Participating in masterclasses■ Providing training in music promotion techniques, including community music outreach and audience interaction. <p>This training programme will be taught in English, Cantonese, and Mandarin.</p>
